New Trips Added

Three BPX Trails Inventory Trips in Lost Creek Wilderness have been added for June 15, July 13 and September 14. These trips can be "claimed" by a BPX Leader now by going to the BPX Trip Description online and inserting the leader's name in place of John Walters' name. Grover Cleveland, Trails Committee Chair, will be the Trails Inventory Leader and train participants to use SURVEY 1 2 3, an app developed by the USFS, to record existing and potential campsites and trail obstructions. Although all three trips are in the Lost Creek Wilderness each trip is a separate trail.

BPX GEAR CHECKS

These Gear Checks were scheduled several months in advance of the SIP orders. Although viewable on the cmc.org trip schedule registration has been closed in compliance with CMC State directives. Registration will be opened as soon as CMC directives allow.

Two Gear Checks to be held at Cherry Creek State Park midweek May 26th and on the weekend May 29th. Twelve campsites have been reserved for May 26th with twenty-four sites reserved for May 29th.

Gear Checks at White Ranch, Jeffco Open Space, to be held June 23rd and June 26th Ten campsites for each overnight.

Each Gear Check is scheduled for late afternoon arrival through the next morning. We'll make it real - or as real as it can be. You'll get a chance to remember why you said you needed a new air mattress or a chance to try out something besides freeze dried, out-o-the bag food.
